Cayman owns 3.0% of the outstanding shares, Technology owns 0.5% of the outstanding shares, Technology II owns 2.4% of the outstanding shares, SSF3 owns 0.8% of the outstanding shares, and SSFQP owns 8.6% of the outstanding shares.
