They share voting and investment control over all securities owned by Special Situations Fund III QP, LP (QP), Special Situations Cayman Fund, L.P. (Cayman), Special Situations Technology Fund, LP (Tech) and Special Situations Technology Fund II, L.P. (Tech II), respectively. 704,722 shares of Common Stock are held by QP, 249,315 shares of Common Stock are held by Cayman, 34,864 shares of Common Stock are held by Tech and 173,234 shares of Common Stock are held by Tech II. The interest of Marxe and Greenhouse in the shares of Common Stock owned by QP, Cayman, Tech and Tech II is limited to the extent of his pecuniary interest.
